# PRODUCT: ACF3007-XXX 30mm Ultra-soft Case Feet [UL94-HB]




#### PRODUCT DESC:

The AF3007-XXX is a 30mm diameter 7mm high low profile ultra-soft case foot, manufactured as a set of 4 feet (see Kit Parts List). The set of feet are designed to isolate and attenuate vibration transmission between a case (such as a PC or set-top box) and the substrate on which the case sits (such as a table, or surface). The ultra-soft silicone rubber polymer is resistant to both high and low temperatures, and non-marking. Each foot is 'kiss-cut', and as such quickly and easily manually detached from the set for placement. The underside of each foot is coated with an acrylic self-adhesive for permanent application to the case.

Feet are available in a number of softnesses (Shore A), differing ultra-soft polymers, and colours (see Part Numbering Scheme).
